

Minutes of the Online Meeting held on 28.04.2021 at 10:30 AM

1. A minute of silence was observed in the memory of Prof. Rahman and Prof. A. C. Gomes. Fr. Principal expressed the gratitude on behalf of the whole college for the two dedicated persons.
2. Fr. Principal said that the meeting has been called to discuss the actions to be taken in the present COVID situation. Fr. Principal asked for suggestions from the members.

Prof. Da Silva – Students are under extreme mental pressure. Proposed deferring final semester examinations till early June. COVID style question paper to be set. A short break may be given to teachers and students.

Dr. Panchali Sen – Asked whether the last class day remains 30th April for final semesters.

Fr. Johnson Padiyara – Said examinations may be deferred.

Dr. Tapati Dutta – Opined same as Fr. Johnson and Prof. Da Silva.

Fr. Joseph Kulandai – Already completed the classes. Students of Commerce are ready for writing exam.

Fr. Peter Arockiam – Commerce and BMS students are ready for exam.

Dr. Amitava Roy – Examination should not be postponed.

Prof. Sougata Banerjee – Existing time table should be followed.

Dr. S. K. Basu – Examination to be held as per existing schedule.

Dr. Arup Mitra – Some question papers for Commerce and BMS are still pending.
3. Fr. Principal asked Prof. Da Silva to get a feedback from teachers and students about deferment of exam.
4. Prof. Shalabh Agarwal – Number of students coming to the class has gone down significantly. Suggested to call off the classes for one week.
5. Fr. Johnson Padiyara – examinations should be delayed for two weeks.
6. Fr. Joseph Kulandai – Postponement of exam will create more anxiety to the students.
7. Fr. Principal asked whether conducting exam at present will send a good message to the outer world.

8. Fr. Principal – It may not look good to conduct exam in the present scenario.
9. Dr. Partha Pratim Ghosh (Commerce) – Some students have not been able to complete project due to illness.
10. Dr. Ayan Chandra – Examinations may be deferred.
11. Fr. Peter Arockiam – The students should be clearly communicated.
12. Fr. Anil Gomes – Examination should be deferred.
13. Dr. Partha Pratim Ghosh (IQAC) – To defer examination and classes.
14. Dr. Argha Banerjee – to defer examination. Current time is not suitable for extensive academic exercise.
15. Prof. Romit Beed – We can think of a break. Can restrict the syllabus to whatever been covered till now.
16. Dr. Charlotte Simpson – Examination may be deferred.
17. Fr. Principal – The announced time table stands cancelled. The question paper should be somewhat in between regular and relaxed pattern. The syllabus may have to be curtailed in case the last class day is brought forward.
18. The term paper or project viva of Commerce and BMS departments will be held as per the published schedule.
