1.2 Admission process

The admission process starts immediately after declaration of Class XII results of the various Boards.

No candidate shall be eligible for admission after a lapse of more than five years from the year of passing the previous qualifying examination.

The year of admission will not be taken into account while calculating 5 years from the year of passing the previous qualifying examination.

1.3 Registration

A student who is selected for enrolment in a particular course offered by the College will have to complete admission procedures and get himself/herself registered within the notified time period. The Registration of a student is valid for 7 years including the academic year in which the registration was granted.

Section 2: Attendance

A student must obtain a minimum of 75% attendance in each paper individually – (Major/Minor/ Multi-Disciplinary / Ability Enhancement / Skill Enhancement / Value-Added).

- 2.1 A student who has less than 75% attendance will have to seek condonation from the Principal/Vice-Principal on grounds of illness or involvement in extra-curricular activities approved by the College.
 - a) In case of illness, a student must submit a medical certificate along with an application for leave. Leave application must be submitted within three days of the student's absence. Submission of leave-application in itself will not ensure condonation.
 - b) In case of extra-curricular activities, a student must obtain written confirmation of his/her participation from the concerned authorities: Head of Department/Presidents of College Societies/Director of Sports/Director of NSS / NCC officer-in-Charge/AICUF Adviser, countersigned by the Vice-Principal. When calculating the attendance percentage of the students representing the College in NCC and sports, due consideration will be given to the days when they so represented the College. Condonation in each case must be in explicit written form authorized by the Principal/Vice-Principal.
 - c) A student who is condoned will have to pay a condonation fee within notified period of time.
- 2.2 A student will be debarred from appearing for the Semester Examination in the paper/papers in which he/she has less than the required attendance without condonation. However, subject to fulfilment of certain criteria,
 - A student can write the debarred paper(s) in the next appropriate semester. For example, paper(s) debarred in semester 1 in semester 3. The debarred paper(s) of the penultimate and terminal semesters can be written during the supplementary examinations.
 - For each debarred paper, a student has to complete certain number of monitored library work to be decided by the Vice –principals of the respective departments.
 - The student has to obtain minimum 40% marks in each of these assignments.
 - The student will be evaluated only in terms of semester examination for the debarred paper. The original CIA marks will be carried forward.
 - > Fees applicable will have to be paid.

2.3 A student with attendance below 40% in all the papers in a semester taken together may be struck off the College Rolls and such a student will not be eligible for reenrollment.

However, subject to the discretion of the Principal, such a student may be allowed to repeat the semester in the following academic year. The student will not be allowed to move forward to the next semester until he/she completes the said semester with the required attendance. In such a case, the attendance and marks of the said semester cannot be carried forward. This opportunity, if allowed, will be applicable for the following academic year only.

Section 3: Course Structure

3.1 Bachelor of Commerce

NOMENCLATURE OF THE DEGREES

- a. **Bachelor of Commerce (Honours)** Four-Year (Eight Semesters) A student will be awarded the honours degree after completing 176 credits.
- b. **Bachelor of Commerce (Honours with Research)** Four-Year (Eight Semesters) If a student secures a minimum of 75% marks in first six semesters may opt for honours with research in 4th year. The student will be required to complete a research project/dissertation under the guidance of a Faculty member.

Note: Students completing the 4-years programme may join the Master degree programme and complete the same in one year. Also a student completing the B.Com. (Honours with Research) may directly be allowed to join the Ph.D. Programme.

c. **Bachelor of Commerce (exit option)** - A student will be awarded the degree after completing 132 credits. Such a student may join the Master degree programme and complete the same in two years.

EXPLANATION OF THE COURSES

The programme will consist of the following seven categories of courses as given below:

- Major (Core) discipline is the discipline or subject of main focus.
- Major (Core) Electives students will choose courses of their interest in the third/fourth year.
- Minor discipline helps a student to gain a broader understanding beyond the major discipline.
- Multi-disciplinary (MDC) are courses from other disciplines.
- Ability Enhancement Courses (AEC) includes courses in;
 - i. Modern Indian Language (Bengali/Hindi/Alternative English)

ii. Business Communication

The emphasis in these courses is on language, communication skills, critical reading, and academic writing skills to enable students to express themselves coherently in written form and in discussion.

- Skill Enhancement Courses (SEC) are designed to impart practical skills, and hands-on training.
- Value-Added Courses (VAC) include courses in;
 - i. Mulya Pravah –Human Values and professional Ethics
 - ii. Jeevan Kaushal Life Skills
 - iii. Environmental Education
- Course–On Indian Knowledge System (Details to be provided in due course)
- Optional Value Added Course (OVAC) -A Course On NCC. (Details to be provided in due course)
- Internship/Community Outreach will allow students to obtain experience in industry, research labs, business, community service, learning projects. Internship and Community Outreach (NSS) will have to be completed by all students.
- The credit for community engagement and service is to be earned by students devoting a minimum of 45 hours. A student has to earn at least 25 hours of social credit from NSS activities. However, a NCC Cadet who completes the NCC course, will be exempted from this social credit.
- There will be an additional credit for co-curricular activities. A student has to perform co-curricular activities for at least 45 hours to earn this credit.

3.2 Arts and Science

3.2.1. St. Xavier's offers a 4-year (8 semester) UG degree (Honours/ Honours with Research) program. Duration of Registration for a UG degree is 7 years

There are 9 types of courses in the new curriculum:

- 1. Major- The Major Course is the subject in which the degree will be awarded
- 2.Minor-The Minor subjects are generally complementary to the Major subject and are designed to help the student obtain a broader understanding of subjects connected to or beyond the Major course. The second minor will be chosen by the student in the second year of the course.
- 3.Multi-Disciplinary (MDS)- Multi-Disciplinary courses are courses from other disciplines. All students are required to take 3 introductory-level courses, 1 in Semester 1, and 2 in Semester 2.

- 9.Internship- Internship is a novel aspect of the UG program to allow students to obtain experience in industry, research labs, business, community service, learning projects.

Internship is a 2-credit course and will have to be completed by Semester 5.

4-YEAR UG DEGREE (HONOURS WITH RESEARCH/ HONOURS)

 - The research project/ dissertation is for 18 credits. These students will be awarded an Honours with Research degree.
- b) In Semester 8, students not undertaking research will complete three papers for 18 credits in lieu of the research project/ dissertation. These students will be awarded an Honours degree.

For Arts and science Departments, Practical papers will have no mid-semester test as the evaluation is by continuous assessment (CA). Details regarding conduct, testing and marking scheme of practical evaluation (for full practical/composite practical) will be given by your department at the start of the semester.

Section 5: Eligibility Criteria for Appearing for Semester Examinations

- **5.1** A student must have at least 75% attendance in each paper. Condonation may be granted on proper reason.
- 5.2 A student must pay the examination fee and submit the Examination Form by the notified last date. However only those students who fulfil eligibility criteria will be issued Admit Card for the Semester Examination.
- **5.3** A student who has any disciplinary charge against his/her name may not be permitted to appear for the Semester Examination.

Section 6: Re-Enrolment – This rule will be uploaded in due course of time.

Section 7: Pass Marks

7.1 Pass Marks for 4 – Year B.A., B.Sc., B.Com. and BMS Courses:

Multi-Disciplinary	40%
Ability Enhancement	40%
Skill Enhancement	40%
Value Added Course	40%

For calculation of SGPA and CGPA, ALL papers will be considered.

To pass in a composite paper of B.Com. and BMS courses, a student has to secure a minimum of 40% marks in each of the theory and practical components.

In order to pass in a Composite paper of Arts and science courses, a student must obtain a minimum of 30% in each component (Theory and Practical) separately and obtain 40% in aggregate.

7.2 Pass Marks for 3- Year B.A. Programme

40% in each paper.

Section 8: Arrear Papers

- **8.1** An Arrear Paper is one in which a student fails to secure the minimum pass marks.
- **8.2** Arrear paper may arise either through failure or absence. This will be indicated in the Semester Mark Sheet as well as in the Consolidated Mark Sheet. A student will be permitted to appear for an Arrear Paper in the next appropriate semester.
- **8.3** The number of Arrear Papers will be taken into consideration to determine if a student qualifies for 3rd Year. This is not applicable to B.A. / B.Sc. departments.

8.4 This rule is applicable to Arts and Science departments only.

If a student obtains less than 40% in aggregate in a Composite paper, he/she will have to appear only for the Theory component if 30% has been obtained in the Practical component. If a student obtains more than 40% in aggregate in a Composite paper (Theory or Practical) but less than 30% in any one component (Theory or Practical) only that component will become an Arrear paper. The Practical Arrear in both cases will be in the form of a Semester examination if the concerned practical was in the continuous mode of evaluation.

Section 9: Review

- Review is permitted for theoretical papers/ modules of Regular and Arrear, and Supplementary examinations of the penultimate and final semesters and for those practical examinations which are computer based.
- Review is not permissible for Internal Assessment, Lab-based Practical Examinations, Foundation courses and Project/Dissertation.
- For review, supplementary and arrear examinations in any paper, the highest marks among the all marks obtained in that paper will be considered as the final marks.

Section 10: Seeing of Answer Scripts

10.1 A student may apply to see his answer script only after the review process is completed.

A student cannot apply for review after he has seen his answer script. There is no scope for alteration of marks at this stage.

To apply for seeing the answer script, a student need not have earlier applied for Review.

The main purpose of allowing a student to see his answer script is to enable the student to obtain a feedback on his performance.

10.2 Review / seeing answer script is not permitted for Practical papers and Projects.

Section 11: Foundation Course (Value Added Course)

- 2.3. All students enrolled in undergraduate programmes are required to complete the IKS course as per college guidelines within the prescribed timeline to be decided by the respective Vice Principals of the various departments. Further details will be communicated in due course.

3. Optional Value-Added Courses (OVAC)

3.1. The course on NCC has been approved as an optional credit course that be undertaken as part of the Under Graduate Programme. This course is only applicable for students who have enrolled their names under the NCC programme. The course needs to be completed within the prescribed timeline (by the end of the third year i.e. sixth semester) as per college guidelines Further details will be communicated in due course. This course is not open for the students of Department of Education.

NOTE:

- 1)All the above courses will be of <u>2 credits and 50 marks each</u> and shall be effective for students enrolled from the <u>Academic Session 2025–2026</u>.
