



MEMORANDUM OF UNDERSTANDING
Between
St. Xavier's College (Autonomous), Kolkata, India



And
Umeschandra College, Kolkata, India

St. Xavier's College (Autonomous), Kolkata (hereinafter SXC), located at 30, Mother Teresa Sarani, Kolkata, India, and Umeschandra College, Kolkata (hereinafter UCC), located at 13, Surya Sen Street, Kolkata - 700012, India, agree to cooperate in regard to academic and cultural programs based on the principle of reciprocity. SXC and UCC are referred to individually as a "party" and collectively as "parties".

This Memorandum of Understanding (hereinafter MOU) serves as a framework document for both parties to establish and develop their bilateral relationships. This will enhance research and educational processes at both institutions and expand the academic spectrum and cultural awareness among the institutions' respective faculties, staffs and students.

The parties hereby agree as follows:

- Ranma Shygy (CS)*
- A. Both parties will work together to develop mutual agreements for cooperation based on their respective academic, scientific and educational needs. The activities in which specific agreements may be developed include:
1. Exchange of students for study, research, internships and short study tours;
 2. Exchange of academic staff for purposes of teaching, training and evaluation.
 3. Reciprocal assistance for visiting academic staff and students.
 4. Joint activities such as international and national conferences, seminars, lectures, and training programs.
 5. Collaboration in the development of academic materials in audio-visual form through Educational Multimedia Research Centre (EMRC).
 6. Participation of UCC in SXC's Add-on Courses, cultural activities (via The Xaverian Academy of Dance and Music - XADAM), and literary societies (e.g., Jhankar).
 7. Opportunities for UCC to introduce Certificate Courses such as Hospitality Management with support from SXC.
 8. Appointment of UCC faculty by SXC as external paper setters and evaluators for B.Com courses.
- B. Details of the implementation of any particular student exchange or faculty-related activity resulting from this Memorandum of Understanding shall be negotiated between the two institutions as such specific case may arise and will be outlined in a Supplementary Student Exchange Agreement (SEA) or Faculty Exchange Agreement (FEA) between the institutions.
- C. Friendly negotiations: Should there arise any other issues not provided for, both parties shall address such issues through friendly negotiations.
- D. Confidentiality:
1. Both parties will maintain the confidentiality of all Confidential Information of the disclosing party and will not disclose any Confidential Information to any employees or to any third party except on a need to know basis. Such confidentiality obligations are subject to applicable law and shall survive and continue beyond the expiration or termination of this Memorandum of Understanding.
 2. "Confidential Information" means in respect of a party, all of that party's


Intellectual Property and information relating to that party's private or business affairs, including, without limitation, technical, financial, operational, administrative, marketing, economic and other information, which is disclosed by one party to the other party, its officers, employees, agents or sub-contractors.

E.


1. Governing Law Clause: Both parties acknowledge that construction and performance of this Memorandum of Understanding shall be governed by the laws of the state.
2. This Memorandum of Understanding reflects the respective institutions' commitments to both educational and academic exchanges as of the date of the Memorandum of Understanding.
3. This MOU shall become effective on the first day after both parties have signed the document, and shall remain in effect for a period of five (5) years from that date. It will be automatically renewed for further periods of equal time, if it is not rescinded by either party. Any necessary modifications or early termination of this MOU require written notice of six months in advance. In case this MOU ceases to be effective on account of termination, the provisions of all valid supplemental agreements shall continue to apply to the extent necessary to secure the implementation of existing activities as agreed upon in the supplemental agreements.
4. This MOU is executed in English in two copies, one for each party, which have equal legal effects.

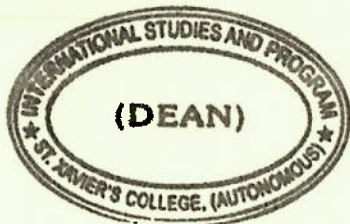




